Corporate Leisure Scheme Terms & Conditions

- a) Company employees can join the scheme by buying a Corporate Subscription at any SRT facility.
- b) The prices are based on a 35% discount on standard subscriptions plus VAT. A minimum of 3 employees must join the scheme in order to receive the discount. Please note that SRT will ask for confirmation of employment and by joining the scheme the subscription holder agrees to sharing information between the company and SRT.
- c) Monthly Direct Debit subscriptions are rolling and do not have a fixed end date. They will continue until such time as you advise us in writing of your intention to cancel.
- d) When paying by Direct Debit you will be asked to make an initial pro-rata payment:
- When starting before the 15th of the month the payment will cover the remainder of that month. Subsequent monthly payments will be taken by Direct Debit.
 - When starting after the 15th of the month, a pro-rata amount for the remainder of the first month plus full payment for the second month is due.
 - A £30 administration fee is due together with the initial payment. If you cancel your subscription, you will be required to pay the administration fee again upon restarting.
 - Identification is required when completing the Direct Debit forms, which includes permanent address, signature and bank account details. A bank card and driving licence are usually sufficient.
- e) If a Direct Debit payment is not received, correspondence will be sent to the payer and, where consent applies, to the subscription holder advising that the amount is still due.
- f) A photo (taken at reception) of the Subscription holder is required and is retained on our computerised membership system as a means of identification.
- g) Corporate annual subscriptions can also be purchased. These are on a fixed term contract and are paid in full at the start.
- h) Subscription holders must present their leisure pass at reception before any facility is used.
- i) The holder is entitled to unlimited use of the subscription purchased: however a subscription does not guarantee automatic access. Subscription holders are advised to book the Gym, Health Suite and Group Fitness Classes in advance to avoid disappointment. Bookings can be made up to 14 days in advance.
- j) The cancellation of Group Fitness Classes, Gym Sessions and Lane Swimming Sessions must be made 6 hours or more prior to the start of the class/session or a late cancellation charge will be applied. The same charge will also apply to no shows. No further bookings will be permitted until this charge has been paid. Please note these charges only apply to activities above if they are included in your subscription.
- k) Subscriptions are not refundable or transferable and use by anyone other than the named person will result in the termination of the subscription.
- l) If a subscription holder fails to comply with Shetland Recreational Trust General Rules and Regulations, or otherwise behaves in an inappropriate manner, we may terminate that person's subscription with immediate effect.
- m) An induction is required before use of a fitness suite is permitted; this is included in the cost of a silver or gold subscription. Please enquire at reception for details.
- n) An induction for the Health Suite in Clickimin Leisure Complex is required before use of the toning chairs is permitted. This is free of charge.
- o) Not all activities are available in all centres. Customers should familiarise themselves with the activities available before purchasing.
- p) All facilities will be subject to periods of closure and no recompense will be made for loss of use.
- q) Shetland Recreational Trust reserves the right to:
- Refuse any application for a subscription
 - Cancel, suspend, withdraw or amend any activity or facility
 - Amend prices and Terms & Conditions at any time
