**GENERAL TERMS & CONDITIONS OF USE**

- MORE4life Annual/1 month Memberships are on fixed term contracts and are paid in full at the start.
- MORE4life Recurring Card Payment Memberships are rolling and do not have a fixed end date.
- If you wish to cancel your Recurring Card Payment membership please notify us by emailing [subscriptions@srt.org.uk](mailto:subscriptions@srt.org.uk) at least 10 days before your next payment is due.
- Family/Household memberships allow unlimited access to all facilities and activities within the scheme for family/household members living in the same household. A family/household may contain up to two adults over 18 and an unlimited number of children under 18 living at the same address. Proof of address may be required.
- It is the paying member's responsibility to: **1) add a valid payment card to their online wallet for collection of monthly payments and 2) ensure any expired cards are updated.**
- A photo (taken at reception) of the Membership holder is required and is retained on our computerised membership system as a means of identification.
- Membership holders must present their leisure pass at reception before any facility is used and must also keep us informed of any changes to their contact details.
- The holder is entitled to unlimited use of the Membership purchased; however a Membership does not guarantee automatic access. Membership holders are advised to book fitness suite, health suite and fitness classes up to 14 days in advance to avoid disappointment. **Please note:** memberships cannot be used for club/group bookings.
- We also operate a concession pay and play scheme (*Access to Leisure*) of **£1 per activity** payable at time of booking for any customer in receipt of certain benefits (see above). Please also refer to [www.srt.org.uk](http://www.srt.org.uk) for more info.
- *Access to Leisure* members may be required to provide proof of eligibility every 12 months.
- We operate a **6-hour cancellation policy**. If you do not notify us of a cancellation, at least 6 hours prior to the start of the class/session, a late cancellation charge will be applied. The same charge will also apply to no shows. No further bookings will be permitted until this charge has been paid. Please note these charges only apply to activities included in your membership.
- Memberships are non-refundable or transferable. Use by anyone other than the named person or knowingly applying for a household membership with false information will result in the termination of the Membership offer.
- Racquet sports are included in the MORE4life Membership but participating non-members will be charged additionally.
- If a Membership holder fails to comply with Shetland Recreational Trust General Rules and Regulations, or otherwise behaves in an inappropriate manner, we may terminate that person's membership with immediate effect.
- An induction is required before use of any gym/fitness suite or toning chairs at Clickimin Health Suite is permitted; this is included in the cost of a MORE4life Membership. Please enquire at reception for details.
- An induction is also required before use of the climbing wall at West Mainland Leisure Centre is permitted. There is a charge for this induction. Please contact the site for details.
- Not all activities are available in all centres. Customers should familiarise themselves with the activities available before purchasing a Membership.
- All facilities will be subject to periods of closure and no recompense will be made for loss of use.
- Shetland Recreational Trust reserves the right to:-
  - Refuse any application for a membership
  - Cancel, suspend, withdraw or amend any activity or facility
